Pritchard, County Commissioner, Acting Supervisor of Registration of said County met in the office of the Supervisor of Registration on the 6th day of November, A.D. 1963 at 10:00 A.M. and proceeded publicly to canvass the vote given for the amendments, together with the absentee ballots (65 ballots were mailed and voted in person) as hereinafter specified A.D. 1963, as shown by the returns on file in the office of said Judge and Supervisor of Registration, respectively, and we hereby certify solely and entirely from said returns as follows: the total number of votes cast were Eight thousand and Sixty-nine (8,069); the total number of electors qualified were Nineteen Thousand Five Hundred and Sixty-three (19,563)
