ments upon the real property benefited by such improvements of serv-  
ices; authorizing the imposition and collection of rates, fees, and  
charges for the service and facilities furnished; authorizing the  
issuance of special obligation bonds of any such district payable  
from the proceeds of service charges or special assessments or both;  
providing for referendum".
