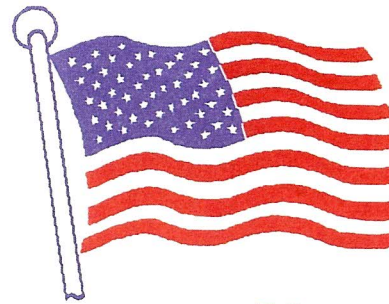

2000 Election Dates

* Presidential Preference Primary

Registration Information

- To register to vote, you must be a United States Citizen, at least 17 years old, and a permanent resident of Monroe County. You must be 18 years old by Election Day to be a qualified voter.
- You must be a registered voter by the time the books close for an election, or you cannot vote in that election.
- You may only vote in elections for which you are eligible. For example, only Key West residents may vote in Key West City Elections.
- In Primary Elections, you may vote only on the candidates in your political party. Therefore, you must declare party preference (or no party) when registering.
- In General Elections everyone votes the same ballot, regardless of party affiliation.
- It is your responsibility to keep the Elections Office advised of your current address.
