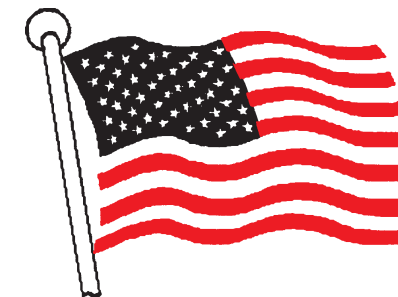

**2008 Election Dates**

**Primary Election - August 26**

Last date to register to vote or  
change party affiliation before the  
Primary Election: July 28

**General Election - November 4**

Last date to register to vote or  
change party affiliation before the  
General Election: Oct. 6

**Primary Elections - Florida is a closed  
primary state. If you wish to register to vote  
in a partisan primary election, you must be a  
registered voter in the party for which the  
primary is being held. All registered voters,  
regardless of party affiliation, can vote on  
issues and nonpartisan candidates.**

A photo ID is required to vote. A voter without ID shall vote a provisional ballot. Any voter who spoils his or her ballot or makes an error may return the ballot to the election official and secure another ballot, except that in no case shall a voter be furnished more than three ballots. To guarantee your vote is counted, you must fill in the oval on your ballot completely:
